



2013-2014 KIDS Planned Changes

Introduction

This document outlines the updates and changes to be made to the KIDS Collection System for 2013-2014. Fields are being added and removed resulting in renumbering of many of the data fields. This document references the new 2013-2014 field reference numbering. A conversion chart has been provided and can be found in Appendix A.

Interface

Several changes to the interface of the KIDS Collection System are anticipated.

- Move the “Search Core Data” button out from under the “Home” menu, and make it a top level menu item.
- On the “Batch History” page, combine the following columns into one column:
 - Errors
 - Core Data
 - Query Results
 - Student IDs
 - Rerun Batch
- Change the wording on the “Submit” button in the View Previously Uploaded Files section of the Batch History page to “Apply.”

The following changes will be made:

- The State Entry Date will be displayed in the output of QUERY records, regardless of whether the school/district is the accountability school/district.

Data Fields

Any field that allows blank as an allowable value will also accept "0." Either blank or "0" will be accepted for 2013-2014. Please see the KIDS 2013-2014 Collection System File Specifications document for the specific fields that will now accept "0" in addition to blank.

It is anticipated that for 2014-2015 blank will not be accepted in any field on any KIDS records.

D2: Accountability School Identifier

Change the field name because we do not use AYP any longer. Formerly AYP/QPA School Identifier

D10: Current Grade Level

- Modify the wording on value "00"
 - 00 = Birth – 2 years old

D25: Concurrent High School Enrollment

- Modify the wording on values "1" and "5"
 - 1 = Any Kansas Board of Regents approved and funded CTE course at a Technical College or Community College.
 - 5 = High school CTE program outside of main campus

D27: Exit/Withdrawal Type

- Modify the wording on the following values:
 - 2 = Transfer to a public school in a different district in Kansas
 - 4 = Transfer to an accredited private school in Kansas or in a different state
 - 5 = Transfer to a non-accredited school in Kansas or in a different state
 - 16 = Moved within the US, not known to be enrolled in school
 - 18 = Student data claimed in error
 - 19 = Transfer to a GED completion program

D28: Special Circumstances Transfer Choice

- Remove the following values:
 - 1 = Transfer using Title I school on improvement choice provision
 - 3 = Student applied to transfer to a school not on improvement but was denied
 - 4 = Student was offered the choice to transfer to a school not on improvement, but declined. Student did not transfer.
