



## 2014-2015 KIDS Planned Changes

### **D83: CTE cPass Proctor Name**

- New Field
- Definition: The name of the educator that should have access to the student's assessment data through KITE. A non-blank value can only be submitted in this field if a non-blank value is selected in D80: General CTE Assessment or D81: End of Pathways Assessment; and D82: CTE cPass Proctor ID has a non-blank value; but it is not required.

### **F21: Letter Grade**

- In order to have the ability to calculate a GPA under the Qualified Admissions pre-college curriculum requirements we will need to collect grades for high school students differently.
- STCO Records submitted with a F9: Student's Current Grade Level of 12-17 and the F20: Course Status of '01 = Completed (Pass), will require one of the following letter grades to be reported on a 4-point scale:
