Elementary School Science

Options in Course Sequences

Science standards at the elementary school level are grade specific; however, may be taught at any time and in any order throughout the school year. For this reason, districts are encouraged to exercise their local control and map the standards to units where they see fit. At the elementary school level much discussion has been had regarding how to group the standards to provide the appropriate depth of rigor throughout the school year. The intent of this document is to provide guidance considering themes and units that could scaffold in a meaningful way for both a balanced implementation and assessment system. The criteria for evaluating the suggested sequence included consideration of developmental milestones / rigor, interconnectedness of concepts and time of year.

The recommended amount of time for science instruction is **45 minutes per day**, however the decision of how much time to devote to science instruction is a local control decision.
