Agency Update

As we kick off the month of March, we are greeted by 'Read Across America' Day! March 1, 2019 celebrates NEA's 'Read Across America' program which focuses on the importance of stories and their impact on our students. Learn more here. The 2018-2019 theme is "Celebrating a Nation of Diverse Readers". We know that literature serves as mirrors and windows for our students; what better way to honor our students than to bring who they are into the framework of our ELA coursework.

Currently, the State Board of Education is reviewing recommendations made by the Legislative Dyslexia Task Force. The Task Force has worked to create legislation advocating for the needs of students with dyslexia and those at risk for dyslexia. As of right now, the recommendations would impact every single teacher under the ELA umbrella (PreK-12). While we will not know the final outcome for a few months, it is important that we start building our capacity now. Meaning, we must start engaging in professional learning around reading, and we must

build a foundation for strong reading intervention focused at both the word and text level. You can read the Legistlative Task Force report here.

Our elementary consultant, Cindy Hadicke, has presented on the science of reading for PreK-3 teachers to over 1,000 teachers across our state. I am hoping to take my 'Reading for the Secondary Teacher' to teachers across our state in the coming months with my 'kickoff' March 1st in Girard. Structure of the Month: Semantic Feature Analysis

This strategy asks students to examine a term or object and then evaluate it for specific features. This can be used before, during, and/or after reading, and students to do this independently, in a group, or with the whole class. You can use this activity to discuss and categorize terminology, or you can use this structure to focus on comparing and contrasting. Students can then use this to shape their writing over similarities and differences.
