Standards and Assessment News

In order to better support teachers, I would like to use this section to highlight not only new resources on the KSDE ELA page, but also, to highlight a teaching structure every month that could be beneficial to ELA practitioners across the state working with all grade levels.

Structure of the Month: [Concept Mapping](#) (Effect Size .60)

A concept map is a 'visual organizer that can enrich students' understanding of a new concept' (Reading Rockets, 2018). These should be used while a student is interacting with content and can be completed independently, with small groups, and as a whole class. This strategy can be used for helping students read complex texts; they can use concept maps to brainstorm ideas for a writing assignment; and they can even use this strategy for interacting with new vocabulary. Additionally, concept maps are not just useful in the ELA classroom, but they can be used by students in any course to increase their interaction with the content.

ELA News:

As an agency, we are tasked with reviewing our standards every seven years. Our handwriting standards are due for review, and so I would like to start this process of review by sharing a Google Form. While we are obligated to review the standards, we are not required to make changes. Thus, our first goal is simply to collect comments from you all and any other stakeholder. Please take some time to review our standards and comment as you see necessary. Once comments have been collected, I will assemble a team to review the comments and determine the extent of work needed to address the comments. You can access the form [here](#). The form will close at the end of March and comment review will take place by the summer.
