Standards and Assessment News

In order to help teachers utilize our standards as a tool for scaffolding, the new Elementary Consultant (Cindy Hadicke) and I created a vertical alignment document for our Kansas ELA Standards. This document is meant to function like a scope and sequence document that school districts, curriculum leaders, and teachers can use to assess resources and prepare appropriate supports for our kids.

You will also find a revised version of our state literacy guide. In 2010, KSDE published our state literacy plan with a guide to teaching literacy. While this document was incredibly comprehensive and could be utilized as a great resource for teachers, its horizontal design and birth through grade 12 layout made it very overwhelming for viewers. We have reworked the document so that it can be read in a linear fashion, and we broke it into age/grade-level sections. This document will be republished in the coming weeks.

Additionally, we are working on creating parent brochures that can be accessed by parents and educators alike and discuss the literacy skills that students will be working on in each grade while also outlining the elements of school redesign that will most impact the grade. While there are many resources available to parents outlining ELA outcomes, these brochures will directly connect what is happening in the classroom to Kansas Redesign.
